FINAL JUDGMENT AND ORDER OF ON TERPLEADER DISBURSEMENT

On the Joint Motion for Entry of Final Judgment and Order of Interpleader Disbursement filed by Defendants Trisha Vacknitz and Amanda Vacknitz, the Court finds, ADJUDGES, and ORDERS as follows:

This suit involves a dispute regarding the proceeds of a group life insurance policy payable by Aetna Life Insurance Company ("Aetna") insuring the life of Walter Vacknitz. On October 10, 2019, an Order (ECF No. 13) granting Prudential's Motion for Interpleader was granted, allowing Aetna to deposit the disputed funds into the registry of the Court. On or about November 14, 2019, Aetna deposited the sum of \$407,407.13 (the "Funds") into the registry of the Court, and was terminated as a party.

The remaining parties have resolved their dispute and submitted a Joint Motion for Entry of Final Judgment and Order of Interpleader Disbursement, evidencing the financial terms of the settlement. Therefore, pursuant to the agreement of the parties, and the record in this matter:

IT IS ORDERED that from the Funds, Amanda Vacknitz is entitled to and the Clerk shall disburse to her Twenty-Five Thousand Dollars (\$25,000.00), payable to: "Dwane Todd Law

Firm PLLC Trust Account" and mailed to: Dwane Todd, Dwane Todd Law Firm PLLC, 405 Main St., Suite 602, Houston, TX 77002.

IT IS FURTHER ORDERED that from the Funds, Trisha Vacknitz is entitled to and the Clerk shall disburse to her Three Hundred Eighty-Two Thousand Four Hundred Seven Dollars and Thirteen Cents (\$382,407.13), payable to: "Interpleader Law, LLC IOLTA" and mailed to: William J. Perry, Interpleader Law, LLC, 9015 Bluebonnet Blvd., Baton Rouge, LA 70810.

IT IS FURTHER ORDERED that One Hundred Percent (100%) of any accrued interest on the entirety of the Funds deposited, less any assessed fee for the administration of the Funds, shall be disbursed to Trisha Vacknitz, payable to: "Interpleader Law, LLC IOLTA" and mailed to: William J. Perry, Interpleader Law, LLC, 9015 Bluebonnet Blvd., Baton Rouge, LA 70810.

IT IS FURTHER ORDERED that this matter is hereby dismissed with prejudice. It is so ORDERED.
