CONSENT JUDGMENT

The Court has reviewed Defendant-in-Interpleader’s Motion for Consent Judgment and Disbursement of Registry Funds. (Doc. 34.) For good cause shown, **CONSIDERING** that the remaining parties, Carol Kay Miller and Deborah Vagotis, have agreed and consented to the following amicable distribution of the Funds placed into the registry of this Court, the parties have consented to accept said amounts as full and complete payment from said insurer, and have consented to release said insurer and each other from any and all further liability in this matter, of any nature whatsoever, the Motion for Consent Judgment and Disbursement of Registry Funds is hereby **GRANTED**.

IT IS ORDERED that, from the \$251,340.69 insurance death benefit which has been deposited into the registry of this Court (the “Funds”), Carol Kay Miller is entitled to and the Clerk shall disburse Forty Thousand Dollars (\$40,000.00), payable to “Magellan Law IOLTA Trust Account” and mailed to: Paul E. Deloughery, Magellan


1 Law, PLC, 10617 North Hayden Road, Suite B-100, Scottsdale, AZ 85260; and Deborah
2 Vagotis is entitled to and the Clerk shall disburse Two Hundred Eleven Thousand Three
3 Hundred Forty Dollars and Sixty-Nine Cents (\$211,340.69), payable to “Interpleader
4 Law, LLC IOLTA” and mailed to: Michael J. Hoover, Interpleader Law, LLC, 9015
5 Bluebonnet Blvd., Baton Rouge, LA 70810.

6 **IT IS FURTHER ORDERED** that Carol Kay Miller and Deborah Vagotis shall
7 accept the aforesaid settlement in full and complete acquittance, release, and discharge of
8 The Prudential Life Insurance Company of America and each other from any and all
9 claims and liability, past, present and future, which either had or may have had against
10 said insurer or each other related to insurance policy number L8597382, which is the
11 subject of this matter.

12 **IT IS FURTHER ORDERED** that any accrued interest, less any assessed fee for
13 the administration of the Funds, shall be disbursed to Deborah Vagotis, payable to
14 “Interpleader Law, LLC IOLTA” and mailed to: Michael J. Hoover, Interpleader Law,
15 LLC, 9015 Bluebonnet Blvd., Baton Rouge, LA 70810.

16 **IT IS FURTHER ORDERED** that, upon payment and distribution of the
17 amounts specified hereinabove, this matter shall be dismissed, with prejudice.
