**FINAL JUDGMENT AND
ORDER OF INTERPLEADER DISBURSEMENT**

Before the Court is the Joint Motion for Entry of Final Judgment and Order of Interpleader Disbursement. (Doc. No. 66). This case involves a dispute regarding the proceeds of a group life insurance policy payable by Sun Life Assurance Company of Canada (“Sun Life”) insuring the life of Timothy L. Jordi. By Order on October 1, 2018 (Doc. No. 39) granting Sun Life’s request for interpleader relief, Sun Life deposited the disputed funds \$328,504.50 (the “Funds”) into the registry of the Court.

The remaining parties have resolved their dispute and submitted a Joint Motion for Entry of Final Judgment and Order of Interpleader Disbursement, evidencing the financial terms of the settlement. Therefore, pursuant to the agreement of the parties, and the record, the Court finds as follows:


That from the Funds, the Estate of Timothy L. Jordi is entitled to and the Clerk shall disburse to it Fifty Thousand Dollars (\$50,000.00) of the Funds, payable to: “Pepper Law PLC Trust Account” and mailed to: Matt Pulle, Pepper Law PLC, 4201 4th Ave N #1550, Nashville, TN 37219.

That from the Funds, Barbara Shimmon and Ethan Jordi are entitled to and the Clerk shall disburse to them Two Hundred Seventy-Eight Thousand Five Hundred Four Dollars and Fifty Cents (\$278,504.50) of the Funds, payable to: “Interpleader Law, LLC IOLTA” and mailed to: Michael Hoover, Interpleader Law, LLC, 9015 Bluebonnet Blvd., Baton Rouge, LA 70810.

All of the accrued interest on the entirety of the Funds, less any assessed fee for the administration of the Funds, shall be disbursed to Barbara Shimmon and Ethan Jordi, payable to: “Interpleader Law, LLC IOLTA” and mailed to: Michael Hoover, Interpleader Law, LLC, 9015 Bluebonnet Blvd., Baton Rouge, LA 70810.

This matter is hereby dismissed with prejudice and the Clerk shall close the file.

IT IS SO ORDERED.
