FINAL JUDGMENT AND ORDER OF INTERPLEADER DISBURSEMENT

On the Joint Motion for Entry of Final Judgment and Order of Interpleader Disbursement filed by Defendants Ronald DeLong ("DeLong") and Betty Jean Sanford ("Sanford"), the Court finds, adjudges, and orders as follows:

This suit involves a dispute regarding the proceeds of a life insurance policy payable by American General Life Insurance Company ("AGLIC") due to the death of Michael Sanford. On May 26, 2021, AGLIC was ordered to deposit the disputed death benefit into the registry of the Court and was dismissed as a party.

(ECF No. 19). On June 9, 2021, AGLIC deposited the death benefit and applicable interest totaling \$262,719.18 (the "Funds") into the registry of the Court.

The remaining parties, DeLong and Sanford, have now resolved their dispute and submitted a Joint Motion for Entry of Final Judgment and Order of Interpleader Disbursement, evidencing the financial terms of the settlement.

Therefore, pursuant to the agreement of the parties, and the record in this matter:

IT IS ORDERED that from the Funds, Ronald DeLong is entitled to and the Clerk shall disburse to him Two Hundred Thousand Dollars (\$200,000.00), payable to: "Interpleader Law, LLC IOLTA" and mailed to: Interpleader Law, LLC, 5800 One Perkins Place Dr., Suite 2A, Baton Rouge, Louisiana 70808.

IT IS FURTHER ORDERED that from the Funds, Betty Jean Sanford is entitled to and the Clerk shall disburse to her Sixty-Two Thousand Seven Hundred Nineteen Dollars and Eighteen Cents (\$62,719.18), plus One Hundred Percent (100%) of any accrued interest on the entirety of the Funds deposited, less any assessed fee for the administration of the Funds, payable to: "Law Office of Daniel R. Duello Trust Account" and mailed to: Law Office of Daniel R. Duello, 426 Cleveland Street, Suite 4, Blairsville, GA 30512.

IT IS FURTHER ORDERED that this matter is hereby dismissed with prejudice.
