FINAL JUDGMENT AND ORDER OF INTERPLEADER DISBURSEMENT

On the Joint Motion for Entry of Final Judgment and Order of Interpleader Disbursement filed by Plaintiff, Diane Turner, as Personal Representative of the Estate of Tyrone McCray-Bey, Jr. (the "Estate"), and Defendant, Shante McCray-Bey ("Shante"), and consented to by all parties, the Court finds, adjudges, and orders as follows:

This suit involves a dispute regarding the death benefits of a life insurance policy payable by Primerica Life Insurance Company ("Primerica") upon the death of Tyrone McCray-Bey, Jr. On February 9, 2022, Primerica deposited the death benefit and applicable interest totaling \$613,077.30 (the "Funds") into the registry of the Court and was dismissed as a party.

The competing claimants, the Estate and Shante, have reached a resolution concerning division of the death benefit, and they have submitted a Joint Motion for Entry of Final Judgment and Order of Interpleader Disbursement, evidencing the financial terms of the settlement. Therefore, pursuant to the agreement of the parties, and the record in this matter:

IT IS ORDERED that from the Funds, the Clerk shall disburse to counsel for the Estate Sixty-Eight Thousand One Hundred Six Dollars and Seven Cents (\$68,106.07), payable to: "Kendus Law LLC" and mailed to: Kendus Law LLC, 300 East Lombard Street, Suite 840, Baltimore, MD 21202.

IT IS FURTHER ORDERED that from the Funds, the Clerk shall disburse to The Tyrine

McCray-Bey Trust One Hundred Thirty-Six Thousand Two Hundred Thirty-Two Dollars and

Fifty-Nine Cents (\$136,232.59), plus Thirty-Four Percent (34%) of any accrued interest on the

entirety of the Funds deposited, less any assessed fee for the administration of the Funds, payable

to: "The Tyrine McCray-Bey Trust" and mailed to: Kendus Law LLC, 300 East Lombard Street,

Suite 840, Baltimore, MD 21202. The trust shall be administered on the terms as set forth in

Exhibit A attached to the parties Joint Motion.

IT IS FURTHER ORDERED that from the Funds, the Clerk shall disburse to counsel for

Shante Four Hundred Eight Thousand Seven Hundred Thirty-Eight Dollars and Sixty-Four Cents

(\$408,738.64), plus Sixty-Six Percent (66%) of any accrued interest on the entirety of the Funds

deposited, less any assessed fee for the administration of the Funds, payable to: "Interpleader

Law, LLC IOLTA" and mailed to: Interpleader Law, LLC, 5800 One Perkins Place Dr., Suite

2A, Baton Rouge, LA 70808.

IT IS FURTHER ORDERED that this matter is hereby dismissed with prejudice.
